Capo Valley High School



- This week will sit down and look at secondary staffing for Mandarin. There will be 3 Mandarin teachers so want to consider hiring a full time teacher.
  Also remind the District of what they committed to support for the program.
- Capo Valley is the District Vaccine Pod Site
  - Doing about 350/day now, hoping to ramp that up to 700 in the coming weeks
- T-Shirt Design Contest
  - Capo Valley will buy shirts for the students, if parents are interested, Mr. Misustin can help get those ordered perhaps through PTSA
  - Mr. Misustin will forward the designs
- Newhart Middle School
  - More information will be shared about upcoming parent nights
  - Thank you to Ursula and Ms. Loh for all of their help and great ideas for Lunar New Year. It was great to share the tradition and for adults to be making connections with the kids. It was a really great experience enjoyed by both the kids and the adults.
- Bergeson Elementary
  - Staff intervention
    - Met today to discuss
    - Agreed that small group facetime is what will be needed. Every teacher will set up time for either small group or individual. All teachers agreed to at least 20 mins/week
  - New Mandarian Immersion Aide is going well
    - She is in the library and able to support onsite and online
    - Each teacher gave a group of 4 students (total of 8 kids/teacher)
  - Open House
    - Started those discussions today. Looking for kids to create some content in class, Mr. Hauser to do an introduction.



#### Kinder Enrollment

- Will have 2 classes, not full at this point, but anticipate increased interest as we get closer to the beginning of the school year
- Digital Bergeson Sign
  - District is refreshing the sign and will handle future maintenance
  - To do a two-sided sign, District is asking for BESF, PTA, MIP to fund \$10,000 (cost of one side)
  - Eric made a motion to approve \$3333 as a one time expense for the Bergeson sign. Melody seconded. Motion passes.

  - May want to review the bylaws to see if we could invest some of the money that is sitting in the bank
- Budget
  - Updated budget includes changes discussed at February meeting
  - Elementary Testing
    - STAMP4S testing will happen for 4th and 5th grade
      - \$2000 for 4th & 5th
  - Middle School Testing
    - Ms. Murphine wants to provide the exact numbers, but we paid for about 17 tests that didn't get used
    - Ms. Murphine will get a full quote for the necessary STAMP testing for all grade levels
  - High School Testing
    - Consider doing testing throughout high school to be able to compare year over year
    - For now, we will need to get the cost for 9th & 10th
  - Will need to adjust Supplemental Tutoring
